- Present entire range of options for public consideration The financial options presented in the survey include the bond levy equalization percentages
- Confidentiality for respondents
- Prioritize transparency for the decision-making process
- Impartiality of survey questions/neutrality of responses
- Representative of the community
- Fiscally responsible approach to collecting public input
- Timely response
- Potentially help define follow-up survey

In total, the survey garnered 2,959 responses. The survey results are included in the packet. A follow-up survey to seek further public input may be solicited depending on direction and guidance from the Board.






I do not support the estimated fiscal costs of Option 2 or 3 and prefer Option 1 to rebuild Highland High School using replacement value funding only.
